NEW CUSTOMER SERVICE AGREEMENT

Term

The initial term of this Agreement shall be effective from the date [Date] of installation of the equipment and establishment of internet services. The term of the Agreement shall be for a period of 1 month.

Fees

The payment for internet services amounts to the subscribed plan current price. The billing shall be commenced on the date of activation of the internet service, and will be due on the 1st of the month for every month thereafter until service is canceled. The Customer agrees to pay all the necessary amount incurred upon receipt of the invoice. The amount shall be paid in US dollars.

If the monthly service charge is more than 7 days overdue (without prior authorization), a \$20 late fee will be applied to the next invoice. At this time services will also be suspended until payment is received.

All plans require auto pay via bank account or credit/debit card. If payment is made via cash or check a \$20 per-month convenience fee will be added to the bill. For any bounced checks, a \$50 fee will be charged to the customer.

Termination

Either Party may terminate/cancel this Agreement by written notice to the other Party. Written/electronic cancellation needs to be a minimum of 14 days prior to desired cancellation date. In case of breach of the terms and conditions herein by any Party, the Party in breach shall remedy it within 30 days upon receiving such notice of the breach (or have reasonable plan for remediation in progress). Failure to remedy the breach will lead to the termination of this Agreement without prior notice.

Indemnification

The Client agrees to indemnify the Company against any claim, damages, cost, loss, expense or any kind of liability arising by the Indemnities in connection with any claims, suits, demands, arising out of this Agreement.

Limitation of liability

The liability of the Client shall be limited to the fees due to the Company under this Agreement. In no event shall the Client be liable for any special, incidental, consequential, or other damages.
